The Community trademark is a single title in the sense that it can be registered, assigned, withdrawn, declared null or expired and the use thereof can be banned ...

The Community Trademark was established by the European Council Directive No. 4094 of December 20, 1993. The Community Trademark provides a single registration covering all the member states of the EU. Community Trademark registrations exist alongside national trademark registrations and provide an alternative to national registration.
